The purchase order and the purchase amount must have reached us no later than **two banking days** before the business day on which the purchase is to be executed. Confirmation of trade will be received after completion of the purchase.

The below can be disregarded if you have previously submitted the documentation:

Kindly enclose, if not enclosed earlier, certified and valid ID documentation (*signatory, name, and phone number*). If enclosed before, but the validation date has passed, we must ask you to enclose a new one.

For legal person, please enclose current documentation showing authorized signatories as well as certified ID documentation for the authorized signatories.

For underaged, both guardians must sign the purchase order.

The minimum purchase amount the first time is 50 000 SEK/5000 EUR, thereafter 10 000 SEK/1000 EUR.
